Activities will include music, costume contests, demonstrations, and numerous other dog-based activities. Exhibitor guidelines are as follows:

- Space rental is \$25
- Space rental for certified non-profit groups is FREE (However, a donation would be appreciated)
- Table rental is \$15 (includes table & 2 chairs)
- Although it is not a requirement, we would appreciate it if you could make a donation or offer a prize for our numerous raffles. Alternately, to enhance the fun for all attendees, please consider hosting a game (Examples: "Tennis Ball Catch" or the "Bobbing for Balls or Bones or Pumpkins")
- Exhibits must be dog friendly and family oriented.
- Exhibit space is approximately 12' x 10'. The event will be held at the Concert Site; therefore all exhibits will be outdoors, so plan for the weather (umbrellas for sun or rain, pamphlet holders for wind, sunscreen, etc.) Tents will be permitted, but must remain within the designated exhibit space. Refunds will not be issued.
- Limited electrical hookup is available upon request.
- Quiet Waters Park will assign all exhibit space and move exhibitors as needed.
- Exhibit hours are 11:00AM – 3:00 PM. Setup and cleanup of the site is the responsibility of the exhibitor. Setup will begin at 9:30AM; cleanup must be completed by 5:00 PM. Quiet Waters Park is not responsible for any loss or damage to exhibit property.
- No vehicles will be allowed to drive onto the field, therefore some carrying will be required for setup and cleanup, please plan appropriately.
- Merchandise may be sold. However, food and beverages may not be sold. Refreshments will be available. For environmental reasons, all balloons are prohibited.
